Purpose

Organizing

- The coordination of cooperative efforts and campaigning carried out by residents to promote the interests of their community.
 - The power lies within the community and is built from the bottom up (grassroots).
 - Community sets its own agenda and is self-determent.
 - Leaders are identified and power is built from within.


Organizing in History


- First recorded strike for higher wages: Philadelphia 1786 by shoemakers.

 - Civil Rights Movement
 - Prison Industrial Complex





Cold Anger in Organizing




Faith-Based Organizing

Organizing around values that are based on a group's **faith and/or beliefs**, which has a mission based on social values of faith, and which most often draws its activists (leaders, staff, volunteers) from a particular faith group.

CHARITY

EDUCATION



Provides a direct service in response to a crisis.

It does not mitigate the issue.



Provides knowledge about a particular issue, its background, and trajectory.

ACTIVISM



A visceral response to an injustice by putting one's body on the line to demonstrate a violation of a person or group of people.

ADVOCACY



Addressing the need for and asking for change to policies and systems.




Community Engagement


