

The GRANTS!



Development Grants will focus on Young Adults working in a health and social services profession seeking additional training to enhance their knowledge and skills. Young adults seeking more broad leadership training to develop specific skills in church or community leadership may also apply for a Development grant. Additionally Young Adults seeking assistance for formal courses related to fields of study in health and social services are encouraged to apply.



Project-Based Exploration Grants are for young adults who desire to pursue a passion project, social enterprise idea, or advance a project they already started. These projects or social enterprises must be community or congregation-based and related to a particular health, social, or justice need in their context.

Funded Example

I am seeking this grant to finish up my BA in Music Therapy. I am required to do an internship of 1,080 hours in order to be able to take my Board Certification Exam. These funds would be used for me to apply to and pay for the unpaid internship or living costs during that time. I am required to be registered as a student during my internship for liability reasons. This means that not only will I be unpaid, I will have to pay a total of \$1200-\$1800 (depending on the length of my internship) to my university to do the internship. This is why I am seeking this grant. The internships I am seeking are to hopefully work with youth/adolescents of color that have experienced trauma, PTSD, and need socio-emotional and behavioral growth and development. This area is incredibly underfunded and cannot afford to pay interns. But I cannot afford to do my calling and passion on my own. As a young, queer, neurodiverse person of color myself, my practice in Music Therapy is to bring myself authentically in orderfor my clients to feel comfortable to do the same. I have often been told by my supervisors that I do things with clients they have never seen before- because I bring my queerness, my brown-ness, and my creative ways of thinking to the table. I know there are youth like me who need a leader to show them how to lead themselves. I am a natural-born leader, and lead within my church as well. As a member of our current search-and-call committee, a past childrens choir director, and constant activist, music and helping youth are two incredibly important aspects of my life. My church family radicalized me, were my confidants, and raised me. If I can provide that same care to these kids who are constantly beat down, even if I make nothing, I am rich in soul and spirit.

Funded Example- Justice Library

To combat the misinformation about minority communities and social justice causes caused by censorship in public schools and libraries, I intend to assemble a collection of relevant and threatened books at my local church to be available as a community resource. This collection will exist as a subset of our existing church library and will be available to both church members and the general public. My team is currently assembling a desired catalog list, including both books that have already been specifically banned and topics that have already been excluded from public education. Topics are to include the experiences, cultures, and histories of minority communities like POC and LGBTQ+ people as well as environmental justice, gun violence, and women's rights. That list is specifically nonexhaustive as the design for this library includes community engagement, with concerned individuals able to contribute or request specific titles or topics. I have seen firsthand the pain caused by a lack of education about complex issues. Growing up in the church, I knew POC and LGBTQ+ who suffered confusion and ignorance because their very selves were deemed too controversial to discuss. I still experience the lack of empathy expressed by Christians who do not understand people different from themselves. Everyone deserves to know themselves and I believe the church can help make up for this lack of education when the rest of the world is too afraid to talk. I first developed the idea for the Justice Library last year, when the first act of Virginia's new governor was to ban "inherently divisive concepts" from our schools. According to the American Library Association, 35 different attempts to ban books were made in Virginia in 2022, targeting 182 different titles. These challenges are most often made in the name of defending children from information and often end up targeting information about those who are already the most vulnerable in our society. When politicians want to keep knowledge from our children, it is only just for the church to speak.




